Producer will assist with limited promotion through Producer's social networks. Produce	r will also
help to connect Host with potential speakers and other resources to make for a success	sful event.

INSTRUCTIONS

File delivery and format

Cornelius Swart does not arrive in advance of the Film screening. Therefore, it is incumbent on Host to ensure receipt of the correct file format and to have tested the file for playback and audio prior to the screening.

We recommend obtaining the file NO LATER than 72 hours prior to screening, and testing for audio and visual projection NO LATER than 48 hours prior to screening. PLEASE DO NOT WAIT until a few hours before the screening to download the film. This almost always leads to complications. Producer is not responsible for any screening failure due to lack of preparation as suggested and described above.
